NOTICE OF PUBLIC HEARING

**UNITED AUBURN INDIAN COMMUNITY
THUNDER VALLEY CASINO WASTEWATER TREATMENT PLANT
PLACER COUNTY**

The United Auburn Indian Community is the owner and operator of the Thunder Valley Casino Wastewater Treatment Plant (Facility) a publicly owned treatment works located at 1200 Athens Avenue, Lincoln, California. The Facility provides sewerage service for the Thunder Valley Casino, a gaming and entertainment facility. Treated wastewater from the Facility is discharged to Orchard Creek, which flows to Auburn Ravine, and is ultimately discharged to the Sacramento River, a water of the United States.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2010-0005, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 28 January 2010. The proposed Time Schedule Order contains a compliance schedule and interim limitations for cadmium, lead, and zinc. Full compliance with effluent limitations is required by 1 January 2017 if effluent polishing is not needed or full compliance is required by 1 January 2018 if effluent polishing is necessary.

The designated parties for this hearing are as follows:

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 15 September 2014**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than **5:00 p.m.** on **15 September 2014**. Written evidence or comments submitted after **5:00 p.m.** on **15 September 2014** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
